



National Evangelical Alliance Development Indicators

An Evangelical Alliance at its best is an expression of the Christian unity that Jesus prayed for, as recorded in John 17, so that the world may believe. While each Alliance is unique as it seeks to enable the Church to advance the Good News of Jesus Christ and effect personal and community transformation for the glory of God, there are common measurable qualities that indicate an Alliance's health and maturity. These qualities include both the organizational and functional sides of an Alliance.

Inclusive Unity

An Evangelical Alliance unites for missional action with an inclusive and active membership of churches, organizations and individuals, covering the broadest possible spectrum of evangelicals who affirm a statement of faith that is aligned with the EEA Statement of Faith.

Representative Voice

An Evangelical Alliance represents evangelicals and others with a prophetic and effective voice to government, media and society.

Relevant Services

An Evangelical Alliance serves its constituency and society with relevant and impactful programs, products and services that advance the Kingdom of God.

Visionary Leadership with Authentic Governance

An Evangelical Alliance has a visionary leadership, responsible and representative governance, and clear structures with efficient processes that hold it accountable to its constituency. It visibly demonstrates diversity of gender, age, ethnicity, denomination and socioeconomic background.

Long-term sustainability

An Evangelical Alliance funds its activities with diverse funding streams such as membership dues, sales, contributions in kind and donations. It manages its finances with integrity and transparency and has people responsible for fundraising & income generation. It also has a leadership development culture, with succession planning at every level of the organization.

Collaborative Nature

An Evangelical Alliance partners with others, provides a neutral space for collaborative action and participates in programs and activities of its Regional Alliance and the WEA.

Healthy Relationships

An Evangelical Alliance maintains healthy relationships among its members, and with people and organizations of other or no faith.
